If a home has a homestead exemption of more than \$146,450; won't this exemption still apply if you don't file bankruptcy within 40 months?

Yes. However, a judgment creditor can often force a debtor into involuntary bankruptcy within the 40 months to limit the homestead exemption to \$146,450. This would then expose any additional equity. That's why you must take other steps to shelter the exposed equity from this contingency and cannot always rely on homestead protection.

How do I calculate my exposed home equity?

Simply subtract your mortgage from your home's fair market value. A \$300,000 home with a \$150,000 mortgage has a \$150,000 equity. If your state homestead law shelters \$20,000, you have a \$130,000 equity vulnerable to a lawsuit.

Important Changes in Florida Law

of 2014?

As of 2014, the Federal estate tax exemption is \$5,340,000. This went up from \$5,250,000 in 2013 and more than tripled the tax exemption ten years ago in 2004 (\$1,500,000). The gifting tax exemption is \$14,000 per year. That means that you may gift \$14,000 per year without incurring any taxes (\$28,000 if married). You must file a gift tax return with the IRS if you gift more than \$14,000 or \$28,000 jointly per year, to anyone other than a spouse, a charity, or a political organization. If you aren't sure if you should file a gift tax return, you should always ask an experienced Estate Planning Attorney.


